THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) and (b) The recommendation of the Administrative Reforms Commission is still to be finally considered by Government. However, the matter was placed before the National Development Council at its last meeting. The Council was generally of the view that no change need be made in the financial year and that it should continue begin from 1st April each year.
