premium products, value additions such as pre-mailing facilities, pick up services, Book Now Pay Later Scheme, Monthly Accounting, Discount etc. have been offered. Customised business packages to suit the needs of corporate customers/service providers are provided. Web-based technology has been inducted in Speed Post Centres and post offices for providing on-line track and race (Speednet) system for tracking of Speed Post articles, various web-based services such as e-bill post for collection of bills at the post office counter, and e-post for delivery of e-mail messages to postal addresses have been introduced. Infrastructure and retail network post offices have been offered to the customers on commercial basis for promotion and sale of their products and collection of bills. Sustained publicity and promotion of premium products and services is being done to make the premium products and services visible to the public. Market surveys are being conducted to analyse the market and environment to make the products more competitive and user friendly.

- 2. Financial products such as International Money Transfer with association of Western Union Financial Services International, distribution of Mutual Funds and Bonds and Pension products for various banks, electronic fund transfer through VSAT network of the Department to facilitate end to end fund transfer and warrant payment schemes have been introduced.
- 3. Various policy initiatives under Tenth Five Year Plan have been taken to increase the revenue, reduce costs, improve productivity, efficiency and quality of postal services to make them more competitive and financially viable. These initiatives include introduction of new products and services, diversification and optimal utilization of the network and resources.
