

REFERENCE TO DHARNA BY  
MEMBERS OF THE METRO-  
POLITAN COUNCIL

DR. BHAI MAHAVIR (Delhi): Mr. Vice-Chairman, with your permission, I wish to draw the attention of the House to the fact that yesterday about thirty Members of the Metropolitan Council sat in Dharna in front of the residence of the hon. Deputy Prime Minister regarding the alleged neglect of the necessities of Delhi in the allocation of funds. It needs to be stated that there has been a unanimous recommendation of the Metropolitan Council, which has representatives of the Congress Party, as well as other parties and members of the Government, that the Union territory of Delhi occupies a special position in the country being the capital and being a centre visited by dignitaries from abroad. Now, if the interests of Delhi are neglected and the grants given to it are not even on the basis of the grants given to other States, it would mean the neglect of various essential requirements such as roads, hospitals, housing and other facilities in Delhi. If this continues there is likely to be the danger of these difficulties growing and not getting solved in the course of these years. Now, the Dharna is just a symbol and a symptom of the growing resentment among the people of Delhi. I would request the Government to take note of it and do the needful.

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): Mr. Vice-Chairman, Sir, I have heard with great attention the general debate on the Budget proposals of this year and I find there have been views
