- (b) if so, whether Government propose to provide cable in sufficient quantity alongwith other equipments to provide telephone connections to expected subscribers and to clear the waiting list of subscribers?
- THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (DR. SHAKEEL AHMAD): (a) No, Sir. There is no waiting list in MTNL. As regards BSNL, waiting list of telephone subscribers has decreased from 18,06,577 as on 31.3.2003 to 17,09,127 as on 31.10.2004
- (b) In MTNL, 8289 cases of new telephone connections were pending as on 30.11.2004 which are being provided progressively on cables and Wireless in Local Loop (WLL). BSNL has also proposed to provide sufficient cable and WLL equipment for clearing the waiting list.
