Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state :

(a) whether it is a fact that there were no Shift Duty Hours in different Kitchens of the employees in the Willingdon Hospital of Delhi before July 1968;

(b) if so, the reasons for the same; and

(c) whether it is also a fact that the same has been introduced some time back ?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH, FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY) : (a) to (c) Prior to August, 1968, there was no shift duty system in the Kitchens as the work was of an intermittent nature. However, this was reviewed and 8-hour shifts are now being observed.

#### **TAX LIABILITY**

765. SHRI SITARAM JAIPURIA : Will the Minister of FINANCE be pleased to state whether Government are contemplating to take any steps which will ensure that no one will be liable to pay more tax than his earnings in a particular year and if so, the details thereof ?

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI) : No, Sir. There is no such proposal under consideration of Government.

The maximum marginal rate of income-tax (including surcharge) under the proposals in the Finance Bill, 1969 is 82.5% and it is attracted when the income exceeds Rs. 2,50,000. The maximum marginal rate of wealth-tax is 3 per cent. and the same is attracted when the net wealth exceeds Rs. 20,00,000.

#### **PROBLEMS OF CALCUTTA**

(a) whether it is a fact that a Committee of the Indian Chamber of Commerce has recently requested the Finance Minister during his visit to Calcutta in the middle of December, 1968 to treat the problems of Calcutta on a special basis; and

(b) if so, whether any steps are being taken by Government to solve these problems ?
