## 17TH ANNUAL CONFERENCE OF INSTITUTE OF TOWN PLANNERS

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHRI B. S. MURTHY) : (a) An amount of Rs. 70,000/- was sanctioned by the Delhi Development Authority for playing host to the 17th Annual Conference of the Institute of Town Planners.

## ZINC AND SUPER-PHOSPHATES ACCUMULATION

761. DR. BHAI MAHAVIR : Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state :

(a) whether it is a fact that there is large accumulation of Zinc and Super-phosphates at the Hindustan Zinc Limited;

(b) if so, what are the reasons therefor particularly in view of the abundant need of all types of fertilisers in the country at present; and

(c) what steps are being taken in the matter ?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO) : (a) There is no accumulation of the stock of zinc except that a quantity of 1,200 tonnes of zinc duly inspected by DGS&D against their pending order is awaiting despatch instructions. The stock of super-phosphate is, however, about 15,745 tonnes.

(b) Sale of single superphosphate is presenting difficulties due to competition from imported diamonium phosphate. As the demand for single super phosphate is seasonal, the material is expected to be lifted in about a month's time when the new sowing season will start. In this connection it may also be mentioned that due to fall in demand for this type of fertilizer, the other indigenous factories producing
