(SHRI D. R. CHAVAN) : (a) Sarabhai  
Chemicals have been purchasing bulk penicillin  
from Hindustan Antibiotics Limited, Pimpri at  
50 paise per mega unit. With regard to the cost  
of production of penicillin it would not be  
possible to make it public as it would prejudice  
the interests of Hindustan Antibiotics Limited  
functioning, as they do, in a highly competitive  
industry.

(b) A statement showing the retail prices of  
vialled penicillin presently in force is laid on the  
Table of the Sabha. It is not clear what is meant  
by retail prices in international market as no  
retail sales occur in that market. If the reference  
is to retail prices in other countries the latest  
information is not readily available. But it may  
be stated that they are generally higher than  
those in India.
