Board Employees Federation demanded that the post of Director, Military Lands and Cantonments, should be a tenure one and the tenure should not be more than 5 years in any case; and

(b) if so, what action Government have taken or propose to take to transfer the said Officers from the posts of Director Military Lands and Cantonments, Southern Command ?

THE MINISTER OF DEFENCE (SARDAR SWARAN SINGH) : (a) Yes, Sir.

(b) There are five posts of Deputy Director, one of which is for the Southern Command. The present incumbents of these posts have not yet completed five years in the same post. There is one post of Director, Military Lands and Cantonments, at Delhi, which is filled by the senior-most officer who cannot be transferred to another post in the cadre.

EXPORT OF SILLIMANITE

844. SHRI M. P. BHARGAVA : Will the Minister of FOREIGN TRADE AND SUPPLY be pleased to state :

(a) the export figures for sillimanite for the last five years;

(b) whether a new levy on the export of silmenite has recently been imposed; and

(c) what steps are being taken to increase its exports?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOWDHARY RAM SEWAK) : (a) Export of sillimanite during the

SYMBOL OF BRITISH CROWN ON THE INDIAN HIGH COMMISSION BUILDING IN LONDON

845. SHRI D. THENGARI : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether it is a fact that the symbol of British Crown is still displayed on the Indian High Commission building in London; and

(b) if so, whether there is any plane under the consideration of Government to. remove the symbol from the building ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a) and (b) Yes, Sir. The decision to remove these symbols has been taken; it is in the process of implementation.

THIRD PARTY ASSOCIATION IN INDO-PAK DISPUTES

846. SHRI SITARAM JAIPURIA : Will the Minister of EXTERNAL AF FAIRS be pleased to state :

(a) whether it has been made clear that the Government of India is not in favour of third party association in the Indo-Pakistani disputes whether in the shape of mediation or arbitration; and

(b) the countries which have offered for mediation in Indo-Pak disputes ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a) Yes, Sir.

(b) No country has recently offered mediation in Indo-Pak disputes.

SETTLING OF DISPUTE WITH CHINA

847. SHRI R. K. PODDAAR : Wi¹¹ the Minister of EXTERNAL AFFAIRS be pleased to state whether her recent statement about settling our dispute with China indicates any change in the attitude of the Government of India on the subject of recovery of our territory forcibly occupied by China ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : No, Sir In her recent statement our Prime Minister reiterated India's willingness to talk with China on a basis consistent with India's territorial integrit

soverignty and national honour, and no interference in each other's internal affairs.

PROPERTIES LEFT BEHIND OF INDIAN AND PAKISTANI NATIONALS

843. SHRI R. K. PODDAR : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) the value of properties Iefl by Indian nationals in Pakistan and held by the Custodian of Enemy Properties, Pakistan, as well as the value of properties left by the Pakistani nationals in India and lying wi th the Custodian of Enemy Properties. India:

(b) what progiess has been made in terms of Tashkent Declaration to have the properties released by the respective Governments;

(c) whether the attention of the Government of India has been drawn, to the fact that the Government of Pakistan has been selling away the left behind properties of Indian nationals; and

(d) if so, the action proposed to be taken in the matter ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a) The value of properties left by Indian nationals in Pakistan, on the basis of claims registered by them with the Custodian of Enemy Porperties, India as on 31 March 1967, is approximately Rs. 101-26 crores. The value of properties left by Pakistani nationals in India and lying with the Custodian of Enemy Properties, India, is approximately Rs. ay 15 crores.

(b) Despite numerous requests made by the Government of India to the Govern ment of Pakistan to discuss the question of restoration of properties and assets seized by the two Governments in connection with Uic 1965 conflict, in terms of Article VIII of the Tashkent Declaration, there has been no constructive response from the Government of Pakistan.

(c) and (d) As soon as the Government came to know of the intended sale of by Pakistan, Indian properties the Government lodged a strong protest with the Government of Pakistan against their cedents for permitting defence establisharbitrary and illegal

849. SHRI R. K. PODDAR : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) what is the total number of cultural attaches in Indian embassies abroad and the names of the countries to which they are assigned: and

(b) what are the qualifications of such cultural attaches and how many of them have knowledge of Sanskrit and Indian history ?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH) : (a.) and (b) Cultural activities in all our Missions, except the one in Nepal, are generally treated as part of the activities of the Information/Public Relations Officers in those missions. In these activities, other officers also take part whenever necessary or possible. In Missions where there are no Press Attaches, this work is done by an officer specifically assigned for the purpose by the Head of the Missions.

It is only in our Mission in Kathmandu that we have, in view of the close cultural links between the two countries, appointed since 1961, a cultural Attache specifically to handle cultural work.

A knowledge of Hindi, an easy familiarity with Ii.dian History and a good grasp of the fundamentals of Indian civiliazation and of Indian achievement in the cultural field are regarded as essential qualifications fo: this post.

The present incumbent, Dr. Ind^u Shekhar, holds inter alia, an M.A. degree in Sanskrit, an M.A. d'gree in Hindi and an M. Litt. degree in Ancient Indian Studies.
