go8. SHRI M. P. BHARGAVA: Will the Minister of INFORMATION AND BROADCASTING AND COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that the Ministry of Home Affairs has given advice that Officers from States should not be allowed to remain on deputation at the Centre for more than three years in a particular post;
- (b) how many Circulation Officers are at present serving in the Office of the Registrar of Newspapers;
- (c) how many of them have been there on deputation for more than three years; and
- (d) whether it is a fact that the posts of Circulation Officers have recently been increased, if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL): (a) Yes, Sir. According to the instructions issued by the Ministry of Finance, Department of Expenditure (not by the Ministry of Home Affairs), the period of deputation of officers from State Governments should not ordinarily exceed one year at a time and should not normally be extended beyond three years.

- (b) Three including one Circulation Officer (Senior). Posts of Circulation Officer are filled by deputation of suitable officers in the grade of Assistant Accounts Officer (now designated as Accounts Officer) or equivalent in any of the organised Accounts Services of suitable Class II Officers (Gazetted) of the Income-tax or Central Excise Departments. The period of depution has not been specified in the recruitment rules.
 - (c) One.
- (d) Yes, Sir. One post of Circulation Officer (Senior) and two more posts of Circulation Officer have been sanctioned in order to intensify the verification of the circulation claims of newspapers.
