

**CAMPS FOR REFUGEES**

901. SHRI JAGAT NARAIN: Will the Minister of LABOUR AND REHABILITATION be pleased to state :

(a) the number of camps established for the refugees who came from Pakistan to India during the last ten years and the number of displaced persons kept there; and

(b) the number of persons out of them provided with employment and the number of displaced persons still living in the camps?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI BHAGWAT JHA AZAD) : (a) No new camps were established for the refugees from Pakistan during the period from 1958 to 1963. During this period, the camps which existed in the Eastern Zone were gradually reduced in number and, by the end of 1961-62, all the camps were closed.

With the new influx from East Pakistan from January, 1964, fresh camps had to be opened. The number of fresh camps which were opened varied from time to time according to the number of migrants who sought admission into such camps. The maximum number of camps which functioned was 105 during January/February, 1965. The number of displaced persons residing in camps likewise varied and was dependent on fresh admissions thereto and dispersals therefrom to rehabilitation sites. According to the statistics of camp population maintained, the largest number of migrants kept in camps at any time was 2,83,937 in January, 1965.

(b) 14,766 families comprising 61,859 persons (including 4,347 families of old and infirm persons and unattached women) are at present in camps. The number of families of new migrants who have been rehabilitated up to 30-9-1968 in agriculture, small-trade, employment etc. is 37,200 approximately.

**FOODGRAINS STORAGE CAPACITY**

902. SHRI JAGAT NARAIN : Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) the total storage capacity for foodgrains available at present in the country both in the public and private sectors;

(b) the proposed capacity in the public sector by 1971-72;

(c) the required capacity for storage of foodgrains by 1971-72; and

(d) the steps Government propose to take to satisfy this requirement and the expenditure so far incurred in this respect ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE) : (a) The storage capacity, both owned and hired, available with the various agencies is as follows:

(In lakh tonnes)

F. C. I.	51	Meant for storage of buffer stocks.
C. W. C.	11	Used mainly for storage by agriculturists and traders, J- but a part of this
S. W. Cs.	9	50 I is available for storage of food-J grains also.
State Governments.	29	Used mainly for procurement and distribution purposes of the State Governments.
Cooperatives.	25	This is mainly meant for storage of agricultural inputs etc. However, part of it is available for transit storage purposes also.

Private Sector : Figures are not available.

(b) and (c) Proposals for the Fourth Five Year Plan are still to be finalised.

(d) Government have approved additional construction of storage of 9.65 lakh tonnes capacity to be completed in the current year and the next, at an estimated cost of Rs. 15.36 crores. The Planning Commission propose to allocate Rs 45 crores for construction of godowns in the Central Sector and a further sum of Rs 18.50 crores for construction of godowns by the C. W. C. and the S. W. Cs., during the Fourth Plan period.

(a) whether there is any proposal under Government's consideration to launch a "Service Co-operative Scheme" under which tractor and other materials required for agriculture may be given on a nominal hire for use of the small farmers;

(b) if so, what are the details thereof; and

(c) if the answer to part (a) above be in the negative, what are the reasons therefor ?]

खाद्य, कृषि, सामुदायिक विकास और सह-कारिता मंत्रालय में राज्य मंत्री (श्री एम० एस० गुरुपादस्वामी) : (क) चुनी हुई सहकारी समितियों द्वारा ट्रैक्टरों तथा अन्य कृषि यंत्रों के लिए सेवा केन्द्र स्थापित करने और कृषि यंत्रों में 'कस्टम सर्विस' उपलब्ध करने की एक योजना राष्ट्रीय सहकारी विकास निगम द्वारा स्वीकृत की गई है। इस योजना के अन्तर्गत छोटे किसानों के लिए चुनी हुई सहकारी समितियों द्वारा उपलब्ध की जाने वाली 'कस्टम सर्विस' की सुविधाओं का उपयोग निर्धारित भाड़ा अदा करके करना सम्भव होगा। चुनी हुई सहकारी

समितियों को राष्ट्रीय सहकारी विकास निगम द्वारा सम्बन्धित राज्य सरकारों के माध्यम से सहायता दी जाएगी।
