EXPORT OF ALUMINIUM

1087. DR. (MRS.) MANGLADEVI TALWAR: Will the Minister of PETRO-LEUM AND CHEMICALS AND MIN-ES AND METALS be pleased to state:

(a) whether Government have permitted exports of aluminium against specific requests from producers beyond the original deadline that is the 31st December, 1968; and

(b) whether the export of aluminium is likely to continue till the recessionary conditions in the country subsides?

THE MINISTER OF STATE THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO): (a) and (b) Yes, Sir. Following representations made by the aluminium producers regarding enquiries for the purchase of aluminium metal received by them from abroad, it has been decided, after reviewing the internal demand and supply position, to continue the policy of export of aluminium and semis by the Indian producers beyond 31st December, 1968, and during the year 1969-70. With a view to ensuring that the export commitments of the producers do not create scarcity conditions in the country, it has been decided to review quarterly the position regarding production, internal demand and likely export commitments.
