1158. SHRI SURAJ PRASAD : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether Government have decided to implement fully the report of the Khosla Commission in regard to Delhi Policemen ;

(b) if so, what is the date from which its recommendations will come into force; and

(c) if they are not to be implemented, what are the reasons therefor?]

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) and (b) On 21-10-1968 an incident was reported at Police Station Paharganj that in the Swatantra Bharat Steel Industry, some persons were injured during the course of a demonstration staged by some workers. The local police have registered a case in this connection which is under investigation.

A complaint was also received from Shri Ahuja and it was duly enquired into.
