THE VICE-CHAIRMAN (SHRI M. P. BHARGAVA): I have to inform Members that I have received the following communication from the Sub-Divisional Magistrate, Parliament Street, New Delhi, dated the 9th August, 1968 :-

"I have the honour to inform you that I have found it my duty in the exercise of my powers under section 64 of The Criminal Procedure Code I

to direct that Shri K. Chandrasekha-ran. Member of the Rajva Sabha be arrested under section 188 IPC for taking out a procession and shouting slogans in defiance of thg prohibitory orders promulgated under section 144 Cr.P.C. at the junction of Church Road-Brassey Avenue. New Delhi, at 11.10 A.M.

Shri K. Chandrasekharan, Member of the Rajya Sabha, was accordingly arrested at 11.10 A.M. and is being produced before the Judicial Magistrate, Parliament Street. New Delhi, for trial today."

SHRI BANKA BEHARY DAS (Orissa): Is it for seeking some justice to Kerala that they have been arrested?

THE VICE-CHAIRMAN (SHRI M. P. BHARGAVA): I have read the message as it has come to me.

SHRI BANKA BEHARY DAS: I am told that they were having the demen-stration because Kerala was being neglected, because the rice that was promised to be supplied to Kerala has not been sent, and al'jO in the matter, of locating some Central sector projects in Kerala. I want to know the real position and Government may inform us of the causes of this happening.

SHRI CHITTA BASU (West Bengal): Sir, Mr. Chandrasekharan and other Members of Parliament today, leading a procession wanted to come to Parliament to meet the Prime Minister and other Members of Parliament and hand over to the Prime Minister a memorandum in which is included the following demands:-

Adequate quantity of rice should be supplied to the State of Kerala regularly.

The food subsidy, recently withdrawn by the Central Government, should be restored immediately.

Effective steps to eradicate the regional imbalances resulting from past neglect, and also to raise the per capita income of Kerala to the All India level in the Fourth Plan.
