- (c) Tractors are usually imported from USSR in the 14 to 20 Heise Power range, but these are not classified as agricultural implements. No agreement for such tractors has so far been concluded this year

## Australian proposal to Liberalise Export Quota From India

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD SHAFI QURESHI) (a) to (c) The Australian Government have from time to time, considered requests for the inclusion of additional items of export interest to Less-Developed Countries, including India, a. also for increase in quotas for the items included in the Australian Scheme of Tariff Preferences for Less-Developed Countries. The last list of such items was announced by the Australian Government in February this year.

### COAL MINING FROM DAMODAR RIVER BED

708 SHRI M ASAD MADANI Will the Minister of STEEL, MINES AND METALS be pleased to state

- (a) whether Government's attention has been drawn to the mining of coal from the river bed of river Damodai in the District of Hazaribagh in Bihar by some private entrepreneures during the summer when the river goes dry, and

THE DEPUTY MINISTER OF STEEL. MINES AND METALS (CHOWDHARY RAM SEWAK) and (b) The State Government of Bihar are aware of such coal mining and it has been reported by them that private parties hold statutory leases for areas comprised of Damodar river, there are, however, certain disputes pending in the Court and the parties have been allowed to continue in working possession till the Court cases are decided

### INDEFINITE SUSPENSION OF TRAIN SERVICES BETWEEN KHADA AND CHITAUNI

(a) whether it is a fact that passenger trains between Khada and Chitauni

stations on the Gorakhpur line of North Eastern Railway have been suspended indefinitely from 15th July. 1968 due to floods in river Gandak; and

(b) if so, by what time the line is expected to be reopened and the loss likely to be sustained by the Railways as a result of the suspension of service?

# THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) Yes.

(b) In view of the continuing flood in the Gandak river affecting the railway embankment, no date for resumption of traffic can be given at present. The loss of revenue on this account has been roughly estimated at about Rs. 1000 per day.

DETACHMENT OF 1ST CLASS COMPART-MENTS ETC. FROM ASSAM MAIL

- 712. SHRI G. BARBORA: Will the Minister of RAILWAYS be pleased to state:
- (a) the reasons for detaching some 1st class, 2nd class and 3rd class bogies

- as well as the dining car from the Assam Mail in between Gauhati and Dibrugarh;
- (b) what arrangements are being contemplated to remove the inconvenience to the passengers thereby; and
- (c) whether the Railway authorities propose to run a passenger train between Gauhati and Tinsukia?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) 3Up/4Dn metre gauge Assam Mails were running with diesel locomotives over their entire run between Barauni and Tinsukia. In order to conserve diesel locomotives urgently required for movement of essential goods traffic, these trains have been placed under steam traction between Lumding and Tinsukia, with effect from 6th April 1968, necessitating a reduction in their loads.

- (b) An analysis of utilisation has revealed that the existing reduced accommodation between Gauhati and Tirsukia is adequate for the quantum of traffic on this section.

#### CAPITAL EXPRESS
