SPECIAL ARRANGEMENTS FOR SCHOOL CHILDREN TRAVELLING ON RAILWAYS

Compact accommodation for student parties is also arranged to the extent feasible. Every effort is made to meet the requirements of student parties proceeding on educational tours by rail.

INCREASE IN PRICES OF FOOD-STUFFS IN DINING CARS AND RAILWAY RESTAURANTS

- (a) whether it is a fact that the prices of tea, coffee, vegetarian and non-vegetarian meals have been increased to a great extent in the dining cars on the Railways recently; and

THE MINISTER OF RAILWAVS (SHRI C. M. POONACHA): (a) and (b) The prices of tea and coffee sold in Catering establishments on the Railways were revised and increased slightly with effect from 10th April, 1968, due to increase in the prices of ingredients like sugar, tea leaves, coffee powder, milk etc. The tariff for vegetarian and non-vegetarian meals served in Dining Cars or restaurants has not been revised recently, the last revision having been made in May, 1967.
