ANTIBIOTICS PROJECT, RISHIKESH

786. SHRI GANESHI LAL CHAUDHARY: Will the Minister of PETROLEUM AND CHEMICALS be pleased to state:

- (a) whether it is a fact that an antibiotic project was set up at Rishikesh in 1961 with Soviet assistance, and the project is still not in a position to bring their products in the market;
- (b) if so, what are the reasons for so much delay in the matter; and
- (c) by what time the project will be able to supply their drugs in the market?

THE MINISTER OF PETROLEUM AND CHEMICALS AND SOCIAL WELFARE (SHRI ASOKA MEHTA): (a) No. Rishikesh project was not set up in 1961. The agreement with USSR for the supply of equipment was signed in 1962 and the project was completed in 1967. Some products of the factory have already been marketed.

- (b) There has been a delay of about 11 months due to late arrival of equipment from abroad and late supply from indigenous sources. Technological modifications and improvements also contributed to the delay.
- (c) The remaining products, particularly the sterile ones are expected to be placed on the market shortly after the necessary tests are completed successfully.
