are dealt with by the cadre authorities in the light of the criteria that we have laid down.

SHRI B. K. P. SINHA: I do not understand one thing. The Minister said that forty people have been permitted, and he has excluded people working in the nationalised undertakings...

SHRI VIDYA CHARAN SHUKLA: have said excluding Missions abroad.

SHRI B. K. P. SINHA: . . . how can this permission be given because since 1956 the largest religious group, Hindus, cannot have two wives. The Christians from a long time before that cannot have two wives. How can that permission be given? On what basis, in violation of those laws, permission was given to 40 people to remarry when their wives were alive?

SHRI VIDYA CHARAN SHUKLA: I will clarify this. No permission is given in violation of law. Only where the personal law of the individual allows a second marriage when the first wife is alive such a permission can be considered, otherwise not.

THE DEPUTY CHAIRMAN: Next question, Mr. Arora.

SHRI ARJUN ARORA: Only one supplementary, Madam.

REDUCTION OF SEATS IN ENGINEERING AND TECHNICAL INSTITUTES

## SHRI D. THENGARI:

Will the Minister of EDUCATION be pleased to state:

(a) whether any steps have been taken to reduce the number of seats in the engineering colleges and institutes for technical education; and

(b) if so, the details thereof?

THE MINISTER OF EDUCA-TION (DR. TRIGUNA SEN): (a) and (b) In view of the present unemployment among technical personnel and uncertainty regarding the future demand for such personnel, the Central Government has formulated a Plan for restricting admissions to technical institutions on a selective basis. The Plan is aimed at reducing admissions to those institutions where adequate instructional facilities are not available, and improving generally the standard and quality of training. Only marginal adjustments are made in admissions in those institutions that are fully established and have adequate instructional facilities.

SHRI ARJUN ARORA: Madam, at one time it was assumed that the object for which the Ministry of Education is established is to spread education. Now it appears that the assumption is wrong because having curtailed the quality of education the Ministry of Education is busy in curtailing the quantity also. May I know, Madam, what has been the result of this ill-advised policy of the Government and what is the percentage of admissions to the various Engineering colleges curtailed this year because I am told that as a result of this policy the admissions to Engineering Colleges have been about 30 per cent. less than usual.

DR. TRIGUNA SEN: Madam, is not correct that we are curtailing fa-cilities for education. The hon'ble Member is well aware that Engineering colleges and polytechnics were started in different parts of the country on a certain norm for a particular intake in that institution and the required requisite equipments and staffs were It is only in stationed there. after the Chinese aggression, that all these institutions were asked to double their intake. Unfortunately, there are also polytechnics where permission was given to start degree courses, even post-graduate courses. We have seen that the intake is reduced to the actual norm for which the institution was started so that the quality is maintained. We are not curtailing the facilities. But when we addressed the Governments to reduce the numbers according to the capacity, according to the equipments and teachers available to it, they are doing it only with that yardstick in their view. It is not that 30 per cent. has been reduced. We have not got the actual figures as yet. It will be near about 20 to 25 per cent.

SHRI D. THENGARI: May I know whether the Government has taken any survey or made any assessment about our requirements in the engineering and technical fields?

DR. TRIGUNA SEN: No, Madam, as far as the Fifth Five Year Plan is concerned, no assessment has yet been taken, but we are trying to do it.

SHRI ARJUN ARORA: Madam, may I know if, while curtailing the facilities of engineering education . . .

DR. TRIGUNA SEN: We have not curtailed. ∀ر بای چر جلازت ر

SHRI ARJUN ARORA: You have curtailed, as compared to last year. You have yourself said 25 per cent; though the press reports put it at 30 per cent., I accept your figures. I know if, while curtailing the facilities of engineering education, the Government has taken steps simultaneously to provide additional facilities in some other lines where educated young men could go for further education?

DR. TRIGUNA SEN: Yes, Madam; the hon. Member must have seen in the papers that we are trying to increase the seats for science education by about 20 to 25 per cent. in the various universities to meet this problem.

SHRI K. CHANDRASEKHARAN: I would like to know from the hon. Minister whether on a re-assessment of the present situation, any longrange policy has been thought of in the matter of technical and technological education. I would like to know whether new engineering colleges and polytechnics are still being opened. I would also like to know from the Minister whether it will not be suicidal in the national interest, in the long-range interests of the country, to reduce the number of seats in the engineering colleges.

DR TRIGUNA SEN: Let me take the last question first. As I explained, Madam, we are not reducing the number of seats in the colleges. We only ber of seats in the colleges. advised the colleges to admit students according to the teaching staff and equipment that are available. That is number one. Number two, we are number one. Number two, we constantly reviewing the cases with the Planning Commission and the Home Ministry as to what will be our

future requirement. Till we are assuied of the figures of our requirement for five or six years, we do not approve new colleges or polytechnics.

DR. TRIGUNA SEN: Yes, Madam, we have got the information that there are less applications for admission to the colleges.

SHRI M. M. DHARIA: Is it not a fact that there was a lot of confusion about the order that was issued telling the institutions not to have admissions for nearly 30 per cent of the seats in 1968, and till June 1968 several institutions did not admit students cause the order was not clear? May I know from the hon. Minister whether they have clarified their own order?

THE DEPUTY CHAIRMAN: that correct?

DR. TRIGUNA SEN: It is not correct, Madam, because we wrote to the Education Ministers of the States, to meet the Principals, sit together and finalise the list.

PROF. SAIYID NURUL HASAN: Madam, I would like to ask whether, before the Ministry of Education decided that there should be a 30 per cent. reduction in the intake in engineering colleges-I am saying this with a due sense of responsibility and I am quite prepared to give evidence before you—the Government conducted any proper studies about the man-power requirements after five years, because the effect will be felt after five years. Secondly, Madam, why were those universities which had adequate capacity to admit students according to the seats available "advised" to reduce the intake even though they did not want to reduce?

DR. TRIGUNA SEN: Madam, advised institutions which had got the requisite facilities not to reduce. It is

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (PROF. SHER SINGH): (a) to (b) A proposal for reorganisation of Archaeological Survey of India has been received from our Department and is under examination.

PROF. SAYID NURUL HASAN: May I ask the hon. Minister to state whether he would take the trouble of consulting either the Central Advisory

Board of Archaeology or its Standing Committee or any other body of archaeologists before taking a decision in this matter?

PROF. SHER SINGH: Madam, the hon. Member wrote a letter to the Education Minister and the Education Minister wrote to him back assuring him that a good deal of thought would be given taking into account the Department's long standing before any such organisational changes were brought about.

SHRI BHUPESH GUPTA: Madam, is the hon. Minister aware that people do not have faith in the Education Ministry because it is not taking any steps? For example in the Burdwan University contracts are being given to the extent of Rs. 3 lakhs and more to a particular contractor of Howrah by the Vice-Chancellor of the University. The audit report of Bengal has pointed out that that contract was irregular and unfair and it was a malpractice. May I know, Madam, in view of this serious allegation made about the handling of the funds which are now under the Government of India by the Burdwan University, especially the Vice-Chancellor, what steps the Government are taking in order to create confidence among the people?

THE DEPUTY CHAIRMAN: That does not arise out of this question. Next question.
