**SATYAGRAHA AGAINST KUTCH AWARD**

799. SHRI CHITTA BASU Will the Minister of HOME AFFAIRS be pleased to state:

(a) what is the total number of persons arrested for participation in the Satyagraha against Government's acceptance of the Kutch Award;

(b) whether any inquiry was made into the alleged lathi charges on the satyagrahis at Bhuj on the 8th May, 1968; and

(c) if so, the findings of the inquiry?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) 1946 persons were arrested in Gujarat and 896 persons were arrested in Delhi for defying prohibitory orders promulgated under the law in connection with the agitation against Government's acceptance of the Kutch Award.

(b) and (c) An administrative inquiry into the incident has been ordered by the State Government'. The inquiry is still in progress.

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN

SHUKLA) : The Jawaharlal Nehru Sanskrit Vishwa Vidyalaya, New Delhi, had collected some donations and had advertised through hand bills that some film stars will be honoured at a function to be held at 7.30 P.M. on the 5th May, 1968 in the main hall of Vigyan Bhawan. No film star excepting one came. On receipt of a complaint in the matter, a case under sections 406/420/ 120-B, IPC was registered by the Delhi Police. The investigation which is in its final stages will be finalized shortly.
