TEA AND IRON ORE EXPORT

909. SHRI N. R. MUNISWAMY : Will the Minister of COMMERCE be pleased to state :

(a) whether any survey has been made to find out potential markets to other countries apart from Japan and U.K. who are the traditional bulk importer of iron ore and tea so as to capture the market for India's bulk exports;

(b) if so, the result of the survey conducted;

(c) the steps taken to give effect to the proposals; and

(d) if no steps have been taken, what are the reasons for the delay ?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI): (a) So far as tea is concerned, a survey has been conducted in Italy and Netherlands. The information collected through surveys conducted by other agencies in Australia is also available to the Tea Board. Besides these surveys, a trade delegation which visited some of the countries of Middle East and North Africa surveyed the market conditions for Indian tea in these countries.

No surveys as such have been conducted to explore possibilities of iron ere exports, but the MMTC keeps itself infoirred cf market conditions in various countries through their regional offices abroad, and by sending sales teams to potential markets.

(b) and (c) The tea surveys and the visits of the tea delegation mentioned above helped in a better understanding of tea consumption patterns and the market conditions in the countries concerned. Based on their findings, suitable plans for the promotion of Indian tea in these regions have been formulated for implementation through the Tea Board's offices at Brussels, Cairo and Sydney.

(d) Does not arise.
