

**IMPORT OF U.S. GOODS**

Will the Minister of COMMERCE be pleased to state :

(a) whether Government's attention has been drawn to the article published in an American magazine "International Commerce" dated 8th July, 1968 to the effect that India has imported U.S. goods worth 1,000 million dollars in 1966-67;

(b) if so, what is the reaction of the Government of India in this regard; and

(c) the steps taken by Government to restrict import and to become self reliant?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI): (a) and

(b) A statement showing details of goods imported from USA during 1966-67 is attached. (See below.)

(c) The details of the imports show that most of the imports from USA were foodstuffs, machinery, transport equipments, Fertilizers; Non-ferrous metals, raw cotton and other essential commodities necessary for the development of the economy of the country. In pursuance of the Government's declared policy, a very high priority is being given to agricultural production to attain self-sufficiency in foodgrains by 1970-71. Imports of machinery and equipment are also allowed only after strict scrutiny of their need.

**RAW MATERIAL DISTRIBUTION TO SMALL INDUSTRY**

(a) whether it is a fact that distribution of raw material to small Industries in future would be entrusted to the State Governments instead of central agencies; and
