CONVERSION OF METRE GAUGE LINE FROM GUNTUR TO BANGALORE INTO BROAD, GAUGE LINE

*426. SHRI SANDA NARAYANA-PPA: Will the Minister of RAILWAYS be pleased to

- (a) whether there is any proposal for converting the metre gauge line from Guntur to Bangalore into broad gauge line;
- (b) if so, whether any survey has been done in this connection and if so, what is the estimated cost of the scheme; and
- (c) by what time the work on the scheme will be started?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) to (c) There is no proposal unaer consideration for conversion of the M.G. line from Guntur to Bangalore. However, a proposal to lay a parallel B. G. line from Guntakal to Dharmavaram and conversion of the Dharmavaram-Bangalore section into B. G. is under consideration. A Traffic Survey for this proposal has been taken up. It is proposed to take up an Engineering Survey also for this proposal shortly. The detailed financial implications of the scheme will be known only after both the Engineering and Traffic Surveys are completed. A decision regarding the starting of the project can be taken only after the survey reports are received and examined by the Railway Board.

(b) In order to ensure that the right quality of goods are exported and the image of India as a supplier of quality goods is projected in the overseas markets, the Government of India, under the Export (Quality Control and Inspection) Act, 1963 (22 of 1963) has brought a very large number of commodities under the purview of this Act thereby enforcing compulsory quality control and pre-shipment inspection. The goods covered under this Act include forgings and castings.
