

#### APPLICATIONS FOR LICENCES FOR INDUSTRIES FROM ORISSA

**\*437. SHRI BANKA BEHARY DAS:** Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state:

(a) the names of the persons by whom and the industries for which applications have been made for licence for establishment of industries in Orissa during the last ten years;

(b) the names of the persons and the industries for which licences have been given; and

(c) the names of the persons who have not been given licences and the reasons for the same?

**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED):** (a) to (c) The information is being collected and will be placed on the Table of the House.

#### HEAVY PLATES AND VESSELS PROJECT WITH RUSSIAN COLLABORATION

**\*438. SHRI THILLAI VILLALAN:** Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state:

(a) whether there is any proposal under Government's consideration to set up a factory for heavy plates and vessels with Russian collaboration;

(b) whether initial talks have been started in this regard; and

(c) the action taken by the Government of India on the request of the Government of Madras in this regard?

**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED):** (a) No, Madam.

#### POWER TILLERS WITH JAPANESE COLLABORATION

**\*439. SHRIGANESHILAL CHAUDHARY:** Will the Minister of INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS be pleased to state:

(a) whether there is any proposal under Government's consideration to

manufacture power tillers with the collaboration of two Japanese Firms in the near future; and

(b) if so, what are the details thereof?

**THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED):** (a) and (b) A statement is laid on the Table of the House.

#### STATEMENT

(a) and (b) The following four schemes for the manufacture of Power tillers with Japanese collaboration have already been approved by Government:

gers Ltd., Cal- tillers,  
cutta.

Two more proposals for the manufacture of power tillers with Japanese collaboration have been received from M/s. Indequip Engineering Ltd., Ahmedabad for the manufacture of 'Robin' Power tillers and from M/s. Shetakari Sahakari Sakhar Karkhana Ltd., Sangli for the manufacture of 'Yanmar' power tillers. Detailed schemes from these parties are awaited.

#### TRADE DELEGATION FROM MALAYSIA

**\*440. SHRI M. ASAD MADANI:** Will the Minister of COMMERCE be pleased to state:

(a) whether a trade delegation from Malaysia is likely to visit India to sign a trade Pact; and

(b) the names of the countries in South-East Asia with which India has entered into trade relations?

**THE DEUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI):** (a) Yes, Madam

(b) In the Southern & Eastern regions of Asia India has entered into Trade Agreements/Arrangements with Japan, Indonesia, Philippines, Ceylon, the Republic of Korea and Afghanistan. India has also entered into a Treaty of Trade and Transit with Nepal.

#### COMMON MARKET AMONG INDIA AND NEIGHBOURING COUNTRIES

899. SHRI K. SUNDARAM : Will the Minister of COMMERCE be pleased to state :

(a) whether it is a fact that Government have finally come to the conclusion that common market among India and its neighbouring countries, particularly Nepal and Ceylon, is not practicable at the present stage;

(b) if so, what are the basis of this conclusion; and

(c) if the answer to part (a) above be in the negative, the progress so far made to evolve such a common market ?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI MOHD. SHAFI QURESHI) : (a) The stage at which a conclusion can be drawn about any such proposition has not arrived. Meanwhile, efforts are constantly being made to develop closer economic relations with Nepal and Ceylon and even other countries in the region.

(b) and (c) Do not arise.

#### WATER SHORTAGE IN RAILWAY QUARTERS

900. SHRI K. P. SUBRAMANIA MENON : Will the Minister of RAILWAYS be pleased to state :

(a) whether it is a fact that the upper storey residents of Railway Quarters (Blocks 19 to 21 and C1 to C6) at Sewa Nagar and Lajpat Nagar have to face great difficulties due to acute shortage of water in summer season;

(b) whether any representation has been received by Government in this regard; and

(c) if so, the steps taken by Government in the matter ?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA) : (a) Some shortage of water during summer was experienced by the residents of block Nos. 19 to 21 at Sewa Nagar and Block Nos. C3 to C6 at Lajpat Nagar. There was, however, no trouble of water supply to Block Nos. C1 and C2.

(b) Yes.

(c) A ground reservoir, a high staging tank and pumping arrangements have been provided about two months back at Sewa Nagar.

An underground reservoir and a high staging tank have also been provided in Lajpat Nagar colony. Another high staging tank is also proposed to be erected in this colony during this year.
