DREDGING OF THE BRAHMAPUTRA

970. SHRI G. BARBORA : Will the Minister of IRRIGATION AND POW ER be pleased to state whether the Union Government have :aken up any scheme for dredging the Brahmaputra river-bed or any other effective flood-control measure to avert the devastating floods in Assam almost every year?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (PROF. SIDDHESHWAR PRASAD) : Dredging of the river-bed of the Brahmaputra for flood control is considered to be impracticable. However, it is proposed to undertake experimental dredging at a few places to see the feasibility of this as an anierosion measure. Further, it is proposed to concentrate attention on raising and strengthening the existing embankments in Assam and organise proper flood warning and timely maintenance. It is also proposed to examine thoroughly the technical and economic feasibility of detention reservoirs.
