"It is true, as stated by the Honourable Member, that the post was not advertised nor was the appointment made through a selection committee".

However, on verification now, I find that the post was in fact advertised in 1955. The present incumbent who was temporarily acting in the post had not applied for the post. With the approval of the then Education Minister, his case was, however, considered by a selection committee constituted for the purpose along with others and he was selected for the post on the recommendation of the Committee.
