**N I C. RECOMMENDATION ON MACHINERY  
FOR SETTING INTER-STATE DISPUTES**

Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether the attention of Government has been drawn to a statement reported to have been made by the Chief Minister of Mysore which was published in the 'Patriot' of 24th July, 1968 in which he has stated that the creation of a machinery to go into inter-State border disputes as recommended by the National Integration Council meeting recently held at Srinagar will only encourage more disputes ; and

(b) if so, what steps are being taken to curb this tendency?

**THE MINISTER OF STATE IN THE  
MINISTRY OF HOME AFFAIRS (SHRI  
VIDYA CHARAN SHUKLA) :** (a) and (b) Government have seen the Press reports relating to Mysore Chief Minister's statement. He expressed anxiety that the proposed setting up of a machi-

nery for considering linguistic border issues might possibly lead to new claims and counter-claims being put forward in respect of inter-State borders. The National Integration Council of which the Chief Minister, Mysore, is a member, has adopted the recommendation of the Committee on Regional Aspects to the effect that uniform general principles applicable to the country as a whole should be formulated and a machinery set up for solving linguistic border issues expeditiously. This is under the consideration of the Government.
