THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (SHRI BHAGWAT JHA AZAD): (a) Yes, Sir. Delhi University has withdrawn recognition from the Mahavidushi examination conducted by Manila Gram Vidya*

peeth, Prayag and Sahitya Ratna Examination conducted by Hindi Sahitya Sammelan, Allahabad.

(b) The University found from experience that the candidates with these qualifications could not adjust themselves in the classes and that these examinations were conducted by nonstatutory bodies. It has since come to the notice of the University that the Hindi Sahitya Sammelan, which conducts Sahitya Ratna Examination, has been declared as an institution of national importance. The University is, therefore, reconsidering the case of recognition of Sahitya Ratna Examination.

RECOGNITION OF VIDYA VINODINI AND MAHAVIDUSHI EXAMINATIONS

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) and (b) The Vidya Vinodini examination of the Prayag Mahila Vidyapeeth, Allahabad, was recognised in September, 1951 as equivalent to Matriculation examination for purposes of employment under the Central Government. Later the Vidyapeeth split into two rival organisations with the same nomenclature and Claiming to be the original conducting
