#### SMUGGLING OF ANTIQUITIES

\*583. SHRI M. K. MOHTA : Will the Minister of EDUCATION be pleased to refer to the reply to Unstarred Question No. 1481 given in the Rajya Sabha on the 22nd December, 1967 and state :

(a) the measures Government have adopted or propose to adopt to end smuggling of Indian art pieces; and

(b) whether Government also propose to amend the Antiquities Act of 1947 to plug the loopholes?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (PROF. SHER SINGH) : (a) and (b). Export of antiquities is prohibited under the Antiquities (Export Control) Act, 1947. Government are considering various measures to prevent smuggling and exports in contravention of the Act. The State Governments, Customs Authorities and the Police have been instructed to keep close watch on smuggling and unauthorised export of antiquities. Suitable amendment of the Act of 1947 is also contemplated.

#### 'DHARNA' BY CENTRAL GOVERNMENT CLERKS

\*584. SHRI C. ACHUTHA MENON : Will the Minister of HOME AFFAIRS be pleased to state :

(a) whether the police have arrested thirteen Central Government Clerks who tried to stage a 'dharma' before his house recently; and

(b) if so, what is the nature of cases instituted against them?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) and (b). Thirteen persons including 12 Central Government employees were

arrested in front of the residence of the Home Minister on 2nd August, 1968, for violating the prohibitory orders under section 144 of the Cr. P. C. which were in force in that area. A case under Section 188 of the I.P.C., has been registered against them.

(c) whether the amount of aid given in the previous year has been utilised as scheduled?
