

(c) and (d) AboGf 12,000 pilgrims are estimated to have been stranded at Rishikesh during the pilgrim season this year as the transport arrangements available then could cater for only 2,000 pilgrims daily, while 4,000 Pilgrims are estimated to have arrived daily. The Transport Commissioner, Uttar Pradesh, visited Rishikesh and the rush was cleared in about eight days by increasing the number of buses and their seating capacity and also by diverting buses from other regions. There is, therefore, no question of taking any action against any one in this case.

The Uttar Pradesh Government have arrangements in hand for putting more buses on the pilgrim route and to divert traffic along other routes.
