The Government of Madras suggested appointment of Investigation Committees under the Industries (Development, and Regulation) Act, 1951, to enquire into the affairs of 20 textile mills in Madras State.

3 Investigation Committees have accordingly been appointed covering the 20 textile mills suggested by the Madras Government. Further steps, if any, will be considered after the reports of the Investigation Committees are received.

- 2. Though there is no closed textile mills in Pondicherry, the Government of Pondicherry have suggested giving of gurantees of Rs. 7 lakhs and Rs. 50 lakhs to the Cannanore Spg. and Wvg. Mills Ltd., Mahe, and Swadeshi Cotton Mills Co. Ltd., respectively, to enable them to get advances from Commercial Banks. They have also suggested appointment of an expert Committee to enquire into the financial and technical position of the Swadeshi Cotton Mills Cc. Ltd., Pondicherry. An Officers' Group has been set up to consider the request for a guarantee of Rs. 7 lakhs in respect of Cannanore Spg. and Wvg. Mills Ltd., Mahe, while for Swadeshi Cotton Mills Co. Ltd., Pondicherry, the Textile Commissioner has been directed to conduct a quick survey into the financial and technical position of the mills. The request of the Swadeshi Cotton Mills for a Gurantee of Rs. 50 lakhs would be considered after the Survey report is received.
 - 3. The Government of Kerala have not approached the Government of India for assistance.
