रेल मंत्री (श्री सी० एम० पूनाचा) (क) जी हा, लेकिन यह वारदात 15/16-5-1968 की रात को हुई थी। (ख) 15-5-1968 को जब 12 डाउन कुमाय एक्सप्रेस गाडी पूर्वोत्तर रेलवे के बरेली-कासगंज खण्ड पर उझानी और बितरोई रेलवे स्टेशनों के बीच जा रही थी तो कुछ बदमाशों ने जिनमे से एक के पास पिस्तौल थी और दूसरे के पास चाकू थे, यात्रियों को धमकाकर उनसे सामान हवाले करने को कहा। एक यात्री से उसकी कलाई-घड़ी, फाउंटेन पेन, अगुठी और 175 रुपये नकद ले लिये और दूसरे यात्री से उसकी कलाई-घड़ी और 44 रुपये छीन लिए। एक तीसरे यात्री से भी 23 रुपये नकद ले लिए। बरेली शहर की सरकारी रेलवे पुलिस ने भारतीय दण्ड संहिता की धारा 395 के अंतर्गत एक मामला दर्ज किया है और छानबीन की जा रही है। अब तक एक अभियुक्त को गिरफ्तार किया गया है। अन्य अपराधियों को पकड़ने के लिए प्रयास किये जा रहे हैं।

†[THE MINISTER OF RAILWAYS (SHRI C M POONACHA) (a) Yes, the incident, however, occurred on the night of 15/16 May, 1968

(b) On 15th May, 1968 while 12 DN Kumaon Express train was running between Ujhani and Bitroi Railway Stations in Bareilly-Kasganj Section of the North Eastern Railway a few miscreants, one of them armed with a pistol and others with knives, threatened the passengers to part with their belongings. One passenger was relieved of his wrist watch, fountain pen, ring and cash Rs 175. Another passenger was deprived of his wrist watch and cash Rs 44. A third passenger was also relieved of his cash Rs 23 only. The Government Railway Police Bareilly City registered a case u/s 395 IPC and investigation is proceeding. One accused has since been arrested. Efforts are being made to apprehend the other culprits.]
