

(c) The Government Memorandum dated 20th April, 1961 clarifies the position relating to the seniority of direct recruits including those belonging to Scheduled Castes/Tribes with reference to the general principles for determining seniority of various categories of persons employed in Central Services laid down in Government Memorandum No. 9/11/55-RPS dated 22nd December, 1959. These general principles could not be adopted for fixation of seniority of Class III and Class IV employees in the lower formations under this Ministry as it would adversely affect the seniority of ex-servicemen re-employed in civilian posts and surplus civilian employees in Defence installations absorbed in alternative employments under the scheme of adjustment of surpluses and deficiencies. Consequently, the Government Memorandum dated 20th April, 1961 could not be implemented in respect of Class III and Class IV employees in the lower formations.

CHINESE EMBASSY OFFICIALS VISIT TO  
CALCUTTA

\*607. SHRI GANESHI LAL CHAUDHARI: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the two officials of the Chinese Embassy were allowed to visit Calcutta in July, 1968; and

(b) if so, what was the purpose of their visit?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT): (a) Three Chinese Embassy officials were permitted to visit Calcutta after the Chinese Embassy furnished full details as required by us. The permission is conditional upon reciprocal facilities being provided to our Embassy personnel to visit Shanghai on consular business.

(b) The purpose of the visit was performance of consular functions.

CROSSING OF KUKI AND MIZO HOSTILES  
IN UPPER BURMA

\*608. Dr. (MRS.) MANGLADEVI TALWAR: Will the PRIME MINISTER be pleased to state:

(a) whether Government's attention has been drawn to the report that about 200 Kuki and Mizo hostiles crossed into Upper Burma in the last week of June, 1968 on their way to China; and

(b) if so, under what circumstances they have crossed the river and what steps have been taken by the Government of India in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH): (a) Yes, Sir. Government have seen press reports to this effect.

(b) A gang of Mizo-Kuki hostiles managed to enter Burma in two batches in the last week of June taking advantage of the thick jungles and the nature of the terrain along the Indo-Burma border.

The existing security arrangements to intercept such movement across the borders have been suitably strengthened. Movement across the Indo-Burma border within a zone of 40 Kms. on either side, which was hitherto free for residents of the zone has been made subject to a system of permits with effect from 1st August, 1968.

POET RABINDRA NATH TAGORE'S HOUSE IN EAST PAKISTAN

Will the PRIME MINISTER be please to state:

(a) whether it is a fact that Poet Rabindra Nath Tagore's House at Sahajadpur in East Pakistan is in a state of dis-repair and utter neglect;

(b) whether it is also a fact that the Poet's house is being used by the Government of Pakistan to accommodate some of their departments; and

(c) whether the Government of India asked for reports from the Government of Pakistan in this connection and if so, with what results?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI B. R. BHAGAT): (a) and (b) According to press reports "Kachari Bari", Poet Rabindra Nath Tagore's residence in Sahajadpur (East Pakistan) is in a state of dis-repair and neglect. It is understood that the house is being used by the East Pakistan Revenue Department and the first floor is being used as a **Dak Bungalow**.

(c) The Government of East Pakistan has been requested to provide details regarding the state of the residence. The attention of the Pakistan Government has also been drawn to their obligation under the Nehru-Liaquat Agreement of 1950 to protect and preserve this historic residence associated with the great Poet.
