staff rendered surplus on account of simplification or mechanisation of work in the Accounts Offices of Indian Railways would neither be retrenched nor transferred from their existing stations, without their consent. This assurance has not been given specifically to staff of the Traffic Accounts Office of Western Railway at Delhi.

CHANNEL OF PROMOTION FOR GUARDS

*510. DR. B. N. ANTANI: Will the Minister of RAILWAYS be pleased to stale:

- ia) whether it is a fact that according to Rule No. 122 of the Establishment Manual (2nd Edition) issued by the Railway Board on the 1st April, 1968, the guards have a channel of promotion to the higher grade posts of Assistant Station Masters, Deputy Yard Masters, Yard Masters, Section Controllers etc.;
- (b) if so, the number of guards promoted to these posts division-wise and zone-wise, during the last ten years; and
- (c) if not, the steps taken to imple ment the rule mentioned at part (a) above?

THE MINISTER OF RAILWAYS (DR. RAM SUBHAG SINGH): (a) Yes, Sir. The avenue of promotion indicated in that Rule is of general application. The actual position may vary from Railway to Railway as Railways have been authorised to lay down channels of promotion for non-gazetted staff in different categories taking into account the local conditions, in the light of the general principles laid down by the Railway Board.

(b) and (c) Information is being collected and will be laid on the Table of the Sabha.

- (b) if so, whether it is also a fact that on the first day of the Exami nation when the leakage was brought to the ntice of the Contro'ler of Examinations he had detected that seven question paper packets for the examination which were to be held subsequently were tampered with and one Question Paper was missing from each of those Packets;
- (c) whether it is also a fact that the examination for three papers was .cancelled and re-examination of 6000 students of Indian School Certificate Examination, was held in early February, 1969 all over the country; and
- (d) whether Government have since reported the matter to the Central Bureau of Investigation or any such agency for a thorough probe, and if not, the reasons therefor?

THE MINISTER OF RAILWAYS (DR. RAM SUBHAG SINGH): (a) Yes, Sir.

- (b) Yes, Sir. But the leakage was detected by the Supervising Examiner of Centre at Oak Grove School and it was brought to the notice cf the Inspector-in-charge the of Examina tion Centre on the 4th day of exami nation.
