

ries. Separate figures for Allopathic and Ayurvedic hospitals are not readily available.

(b) and (c) Health is a State subject. It is a fact that more persons seek Allopathic treatment, especially in urban areas, and there is a preponderance of allopathic hospitals and dispensaries. However, the State Governments are also providing increasing facilities for ayurvedic education and treatment. The Central Government promotes post-graduate education and research in ayurveda.

(b) whether Government propose to include some of the Members of Parliament also in the Council; and

(c) whether it is proposed to take representatives from the cooperative agricultural sectors, from the State of Bihar also in the Council; if so, the names of those persons?]
