RAMASWAMY): (a) In the Conference of the Chief Ministers held on 19th May, 1968, the question of representation of Scheduled Castes and Scheduled Tribes in services had also been discussed and the Chief Ministers were requested to consider formation of Committees in the States similar to the High-Power Committee set up at the Centre to

review the performance in the recruitment of Scheduled Castes and Scheduled Tribes in different services under the Government.

(b) According to the information available, so far the Governments of Kerala, Gujarat, Rajasthan, Jammu & Kashmir. West Bengal, Tamil Nadu and Maharashtra have set up Committees.
