THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) and (b) A scheme to increase the share of the national carriers in the U.K.-India traffic is under consideration.

AIRLINES OFFICER'S FLIGHT TO KABUL

- 1386. SHRI A. D. MANI: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:
- (a) whether it is a fact that Capt. Huilgol, Director of Operations and Training, Indian Airlines was prevent ed from flying a Caravelle to Kabul by the Aerodrome Officer, Palam on 22nd December, 1968; and
- (b) if so, what are the details of the incident?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Yes, Sir.

(b) Capt. R. P. Huilgol, Director of Operations, Indian Airlines, was scheduled to fly Indian Airlines Caravelle service IC-451 Delhi-Kabul on 22nd December 1968 as Captain under check for the renewal of his licence. He was not accorded clearance to operate the flight, as the local Controller of Aerodromes received information in the morning that Capt. Huilgol has serious defect in vision. The information proved to be correct and it was found that Capt. Huilgol had a cataract on his right eye. In the interests of safety, therefore, Capt. Huilgol was refused clearance and was advised by the Controller to refrain from flying till he is cleared by the Medical Board.
