DIPLOMATIC RELATIONS WITH GERMAN DEMOCRATIC REPUBLIC

- 1450. SHRI G. GOPINATHAN NAIR: Will the Minister of EXTERNAL AFFAIRS be pleased to refer to the reply to the Unstarred Question No. 875 given in the Rajya Sabha on the 6th March, 1969 and state:
- (a) the date on which India established diplomatic .relations with the German Democratic Republic; and
- (b) the status of India's diplomatic representation?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI DINESH SINGH):
(a) The reply to Unstarred Question No. 875 given in the Rajya Sabha on 6th March, 1969 makes no reference to diplomatic relations with the G.D.R.

- (b) The Plan outlay for Goa and the specific projects as well as the amounts to be spent thereon, will be decided after the draft Fourth Plan has been considered by the National Development Council.

DEMAND FOR INDIA-MADE NEPALI KUKMES

1452. SHRI KRISHAN KANT: SHRI A. G. KULKARNI: • SHRI N. R. MUNISWAMY:

Will the Minister of FOREIGN TRADE AND SUPPLY be pleased to? state:

- (a) whether it is a fact that there-has been, of late, great demand for India-made Nepali Kukries from the United States of America, Canada and West Germany;
- (b) whether any quick survey has been made in those countries as also in other countries in order to study the demand;
 - (c) if so, the details thereof; and
- (d) if the reply to part (b) above be in the negative, what are the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (CHOWDHARY RAM SEWAK): (a) India-made Nepali Kukries are exported from India^ But this item is not separately classified under the Indian Trade Classification. It is, however, included in the general category of knives, the-exports of which have been showing a rising trend during the last thr**-years.
