- (c) Yes, Sir. The ownership rights of Minor Forest Produce have been conferred on the Gram Sabhas under the Provisions of the Panchayats (Extension to die Scheduled Areas) Act, 1996 enacted by the Central Government (the then Ministry of Rural Areas and Employment).
