STATE FARMS CORPORATION

- 1519. SHRI G. R. PATIL: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether Government propose to set up a State Farms Corporation; and
 - (b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) and (b) Yes, Sir. The Corporation is being set up to administer the existing Central State Farms in Rajasthan, Orissa, Punjab and Hary-ana; as also the farms to be set up in Mysore and Kerala. It will have an authorised capital of Rs. 7 crores and a paidup capital of Rs. 3 crores inclusive of the existing assets of the Farms worth about Rs. 2 crores. A budget provision of Rs. 1.25 crores has been mads for the Corporation for the year 1969-70. A sum of Rs. 1 crore is intended as contribution to the share capital of the Corporation and the remaining Rs. 25 lakh as a working capita! loan to be given to it.

The main functions of the Corporation will be to produce seeds of food-grains, fibre crops, plantation crops, oilseeds, vegetables, etc. The Corporation will also take up land development work on the lands of the private parties on payment by the parties of the full cost of operations.

The Corporation will start functioning after the budget for the purpose is approved by Parliament
