on his advice were withheld from transmission by the Telegraph Office. Cuttack, the PMG Orissa Circle issued circular instructions to the effect that any doubts regarding press messages from accredited press correspondents should be referred to his office for orders. It has subsequently been further clarified from the P.&T. Directorate by a circular letter to all concerned that such references to the PMsG in case of doubt should only be after such telegrams are transmitted onwards and, only after the transmission of such messages, any action, if necessary, may be taken to refer doubte to the higher authorities.

(a) The waiting list as on 31st December, 1968 has been 1158 at Kolhapur and 397 at Sangli.

- (b) During the last two years 300 connections were given at Kolhapur and 209 at Sangli.
- (c) The delay occurred due to shortage of exchange capacity at

Kolhapur and shortage of underground cable capacity at Sangli.

(d) It is not possible to say exactly when the applicants on the waiting lists will be given connections, as there is shortage of resources with the department to meet the full demands for phone connections.
