RACKET IN STOLEN BRASS BEARINGS

- *639. SHRI A. C. GILBERT: Will the Minister of RAILWAYS be plea-sed to state:
- (a) wheher it is a fact that a racket with the connivance of railway employees in respect of stolen brass bearings with Railway marks which were booked from Jamalpur. Raniganj and other stations of the Eastern Railway and delivered at Mirzapur, was recently unearthed:
- (b) if so, the period for which this racket was being carried on and the total loss incurred by the Railways on this account till the racket was unearthed;
- (c) the number of persons arrested after raids were conducted and the value of bras_s recovered from each of the persons involved in the racket; and
- (d) the measures taken to prevent the recurrence of such rackets?
- THE MINISTER OF RAILWAYS (DR. RAM SUBHAG SINGH): (a) Yes, Sir. A racket in respect of stolen brass bearings booked from Raniganj to Mirzapur has come to light. Another racket involving booking of suspected stolen Railway property consisting of locomotive components in pieces from Jamalpur to Mirzapur has been unearthed.
- (b) The matter is under investi gation.
- (c) 3 Persons have so far been ar rested and the value of non-ferrous material recovered from each of the three persons is Rs. 180, Rs. 10,000 and Rs. 20,000.
- (d) Ths following measures are being taken in this regard:
 - (i) Patrolling by armed Railway Protection Force personnel inside

the workshops at night and posting of armed guards at strategic points;

- (ii) Staff of the Crime Intelligence Branch of the Railway is deputed to collect intelligence regarding culprits and receivers of stolen property, and to organise raids on them.
- (hi) Intensification of checks by supervisor;! officials.
- (iv) Collection of intelligence and raids on receivers of stolen propery by the Central Crime Bureau of the Railway Board
- (v) Checking of non-ferrous material by the Government Railway Police and Railway Protection Force before its booking from Jamalpur] Raniganj stations.
- (vi) Basic security arrangements around and inside the workshops have been further tightened.
