flats of each type and in each area were put into one Scheme and separate draw of lots was made for each Scheme; now flats on plots of 150 Sq. Yds. both in Safdarjang and East of Kailash, are put in one Scheme and the flats on plots of 125 Sq. Yds. in both localities are included in another scheme.

Written Answers

(c) This is expected to eliminate the possibility of too many persons applying for flats in one particular area.

- (b) what improvements have been brought about in this direction;
- (c) whether any assessment or evaluation of its operation has been made; and
 - (d) if so, the details thereof?

THE MINISTER OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOP-MENT (SHRI K. K. SHAH): (a) Yes, Sir.

Written Answers

- (b) A statement is laid on the Table of the Sabha. (See below).
 - (c) Yes, Sir.
- (d) The percentage of samples found adulterated during the years 1966 and 1967 has come down to 25-5 and 25-1 respectively as against 29.8 to 31.1 during the years 1962 to 1965. A larger number of offenders kwere imprisoned during 1966 and 1967 as compared to the previous years.

STATEMENT

The provisions of the Prevention of Food Adulteration Act have been made more stringent by amendment to the Act and the States have been asked to ensure proper enforcement of the Act.

The Salient features of the amendments made, which came into effect from 1-3-65, are as follows :-

- 1. Punishments have been made more deterrent. The minimum punishments" now prescribed for cases of adulteration is im prisonment of not less than six months and a fine of not less than Rs. 1,000/- except that in cases of misbranding or substandard, the discretion has been left to the courts.
- 2. The manufacturer, distributor or dealer of an article of food has to give a warranty compulsorily in writing about the nature and quality of the article to the vendor.
- 3. The court has been empowered to Proceed against a manufacturer, distributor or dealer if during the trial of any offence. The court is satisfied on the evidence adduced before it that such manufacturer, distributor or dealer is also concerned with that offence.
- 4. The presence of only one witness at the time of drawing of the sample has now been made essential instead of two witnesses as previously prescribed.
- 5. Provision has been made for an indemnity bond equivalent to the value of

the article seized by the food inspector when the goods are kept in the custody of the vendor. A heavy penality has been provided in case ol"infringement.

to Questions

6. Concurrent powers have been given to the Central Government to appoint food inspectors and public analysts, thus enabling the Central Government for better and effective implementation of the Prevention of Food Adulteration Act.
