- (b) what are the salient features of the scheme and what amount is likely to be spent for the purpose; and
- (c) the time by when this scheme is likely to be implemented?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) to (c) A scheme for the integrated development of Ajanta and Ellora has been proposed for implementation under the draft Fourth Five Year Plan. Details will be finalized after this plan has been finalised. The salient features are augmentation of water supply, acquisition of land to preserve natural beauty and to prevent haphazard growth, and the provision of additional accommodation.

ROAD CONSTRUCTION IN JAMMU AND KASHMIR AREA

*195. SHRI SYED HUSSAIN: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the details regarding the roads constructed by the Defence Department, Central Public Works Department and Border Road Development Organisation in the entire Jammu and Kashmir area during the last five years; and
- (b) the number of roads likely to be completed during the Fourth Plan period?

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN): (a) The roads constructed by or on behalf of these authorities in Jammu and Kashmir State are as follows:—

Kilometres

- (1) roads constructed (This includes some length of roads—started in 1960). 1,123,4
- (2) roads under construction 144.0
- (3) improvement of existing roads. 700.0
- (b) Four roads under construction at present are expected to be completed during the Fourth Plan period. Some new works may also be taken up during that period. It is not, therefore possible to say precisely how many roads are likely to be completed during the Plan period.
