INCREASE IN FREIGHT RATES OF CARGO FROM INDIA

The West Coast of India and Pakistan USA Conference and the Calcutta, East Coast of India and East Pakistan USA Conference have effected 10% general increase in freight rates which effect from 1st January, 1969 and 11th January. 1969 respectively.

- (b) The Government of India as well as the All India Shippers' Council had lodged protests to the Conferences as a result of which a number of exemptions and relaxations were allowed.
- (c) The increase has been effected on the ground of steady increase in the operational costs of ships.
