individuals or authorities putting up the statues to ensure that they are properly executed. If a statue is to be put up at a public place, the authority which grants permission to the installation of the statue, who would be primarily concerned, could also insist on the statue being properly executed and Central Government does not come into the picture. In so far as Delhi is concerned, permission to instal statues at public places is given by the Central Government and while granting such permission, Government ensure that the statues conform to appropriate artistic standards. To advice the Government on all aspects of installation of statues, an Advisory Committee which included Members of Parliament and other non-officials was constituted in August 1965 under the Chairmanship of the then Minister for Works, Housing and Supply.

PLAYING OF MUSIC BEFORE MOSQUE

(b) The Central Government have examined the judgment of the Supreme Court in Civil appeal No. 25 of 1966, S. K. Pirubux and others Vs. Kalandipati Rao and others. It has been explained to the State Governments that the judgment has only restated the existing law regarding the rights of persons to take out religious processions, as laid down in the

earlier judgments of the varioua courts and that the right to take out processions is subject to such restrictions as may be imposed in the interest of peace and order in accordance with the provisions of law.

THS MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN): (a) Subject to his other engagemente the President has been granting audience to the public once or twice a month. Some of the visitors take the opportunity of presenting petitions or expressing their grievances verbally. Subject to other pre-occu-pations, the Prime Minister also meets the general public daily in the morning and listens to their grievances. The Prime Minister also meets visitors at other times by appointment, at their request, subject to availability of time and convenience.

(b) Shri Puran Singh was allowed to meet the late Prime Minister, Shri Jawaharlal Nehru, on the 31st Marsh.

THE MINISTER OF EDUCATION AND YOUTH SERVICES (PROF. V. K. R. V. RAO): (a) The Government of India will sanction Grant-in aid to State Governments! Union Territory Administrations to reimburse the total expenditure on salaries and allowances upto the year 1969-70 for such of the NDS Instructors as are taken over for employment under the authorities in the State including local bodies on the scale of pay prescribed there. Thereafter commencing from 1st April, 1970, the Central Government would meet only the difference between the pay of the Instructors as fixed by the State Government | Union Territory and the pay being presently drawn by them. The assistance will extend for a total period of five years.
