Concern over crisis in the Handloom Industry

SHRIPENUMALLIMADHU (Andhra Pradesh): The handloom sector, second largest after agriculture in providing employment in the country, is now facing severe crisis. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: Nothing will go on record except the Special Mention. *(Interruptions)* It is under the consideration of the Chairman. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: The plight of handloom weavers in Andhra Pradesh, Tamil Nadu, Karnataka and Uttar Pradesh is miserable and suicides have become a regular phenomenon. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: Chairman has not permitted. That is what I am saying. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: The reason for this is the violation of the Reservation Act of 1985. This Act, which is meant to protect handloom sector from powerloom, is blatantly violated by many powerloom units and they are producing the reserved items, which has resulted in piling of handloom goods. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: Nothing will go on record; only the Special Mention. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: This leads to serious unemployment and penury that shambles the lives of weavers. The handloom sector suffered not only from the competition from powerlooms, but also from steep hike in the prices of yarn. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: Please sit down, *(Interruptions)* Please sit down. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: Compared with 2003 prices, yarn price went up by 97 per cent. Added to that, the artificial scarcity of yarn in the market led to manipulation and exploitation. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: Nothing will go on record. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: In the earlier days of independence, government had given priority for handloom sector and Budget allocation is also high, but nowadays, the Government is thinking that spending money on handloom sector is waste and giving more importance to powerloom and textile industry. This has led to present crisis. ...*(Interruptions)*...

MR. DEPUTY CHAIRMAN: I am aware of it. *(Interruptions)* But the Chairman has not permitted it. *(Interruptions)* The letter was not given to me. It was given to the Chairman. ...*(Interruptions)*...

SHRI PENUMALLI MADHU: In view of this heartrending situation, I urge upon the Government to immediately intervene and come to the rescue of the weaver and ensure strict implementation of the Reservation Act, regular supply of yarn to handloom industry, lower interest credit facilities and applying all welfare schemes, like mediclaim, life insurance, old age pension, Antyodaya to all handloom workers.
