THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) Firm estimates of area and production of summer rice crop sown during the current rabi season would become available only after the close of the Agricultural Year i.e., some time in July-August, 1969.

(b) and (c) The demand for foodgrains like that for other commodities is elastic. One type of foodgrain can also be substituted by another to a certain extent. It is, therefore, difficult to assess there requirements and shortage of rice in the country after the current rabi crop season. Arrangements have, however, been made to import rice from Burma, Egypt, Thailand and Australia.

AREA UNDER DRY FARMING

- 1738. SARDAR RAM SINGH: Will the Minister Of FOOD AND AGRICULTURE be pleased to state:
- (a) whether Government have made any assessment of the acreage which can be brought under dry farming in the country;
- (b) if so, what progress has been made in this regard during 1967 and 1968; and
- (c) to what extent it has helped in augmenting the food production?

THE MINISTER OF STATE IN THEI MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHEB SHINDE): (a) to (c) A statement is attached.

STATEMENT

(a) and (b) The net sown area in 1960-61 was 1,33,154 thousand hectares and that in 1965-66 was 1,35,829 thousand hectares, whereas the figures; for net irrigated areas were 24,634 thousand hectares in 1960-61 and 26.441 thousand hectares in 1965-66. Efforts have been directed towards putting culturable wastelands to plough, wherever it is feasible, with the result that area under cultivable wasteland has decreased from 19 million hectares in 1960-61 to 17 million hectares in 1965-66. Water development has also taken place so that, though there is a net decrease in the area Of culturable wastelands over a period of five years from 60-61 to 65-66 the net area under dry farming has increased only slightly to the extent

ot 865 thousand hectares. Figures for the area for dry farming in 1960-61 •nd 1965-66 are 109.30 million hectares and 108.52 million hectares respectively.

The Government appointed a Wasteland Survey Committee in 1959 to make an assessment of the acreage that can be brought under cultivation. The scope of the survey was restricted to finding blocks of wastelands of IOO hectares and above. Some 4.8 lakh hectares of wastelands were thus located in 13 States. The second survey for locating wastelands in blocks of 1 less than IOO hectares has been taken up under a Centrally sponsored scheme. This work is continuing ind so far 22.8 lakh hectares have been located. The State Governments are allotting these lands to eligible farmers for increasing the area under cultivation. A small portion of these areas comes within the command of irrigation projects and there may be other areas where irrigation facilities may be forthcoming through minor irrigation works, Major portion of the areas, however, goes to increase the acreage under dry farming.

(c) On a rough estimate additional production of food-crops from such areas would be at the rate of 1/3 ton per acre per annum.

NETAJINAGAR SINDHI COLONY AT NAMNER, AGRA

1740. SHRI M. P. BHARGAVA: Will the Minister of LABOUR AND RE HABILITATION be pleased to state:

- (a) whether the Netajinagar Sindhi Colony at Namner, Agra is maintained by the Central Government;
- (b) if so, whether it has been provided with tin roofs in the excessive heat and cold of Agra; and
- (c) whether any representation has been received that infantile mortality rate is extremely high in that colony due to their being exposed to excessive heat and cold?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT REHABILITATION AND (SHRI BHAGWAT JHA AZAD): (a) and (b) Netajinagar Sindhi Colony at Namner, Agra, consisted of 'kachha' quarters with tin roofs, constructed in 1948-49 to provide temporary accommodation to the Displaced Persons from West Pakistan. In response to requests by the Displaced allottees/occupants, they were allowed to stay on in these quarters, all of which, save 4 quarters, were subsequently sold to them. The Central Government are not maintaining this Colony.

(c) No such representation has been received.
