Inscription in Hindi on the milestones in the National Highways in Tamil Nadu

SHRI P. G. NARAYANAN (Tamil Nadu): Mr. Chairman, Sir, I want to draw the attention of the House to the grave situation prevailing in Tamil Nadu after the National Highways Authority's move to have Hindi inscription on the milestones in Tamil Nadu. The Hindi inscription on the milestones is being introduced for the first time in Tamil Nadu. The irony is that this measure is being introduced when the Minister of Shipping, Road Transport and Highways belongs to the DMK Party.

Sir, we, the people of Tamil Nadu, are not opposed to any language, including Hindi, but the House and the Central Government should realise the hundred years old popular movement in Tamil Nadu against imposition of Hindi. Sir, in TamH Nadu, we are following time-tested, two-language formula, and, the Centre should respect the sentiments of seven crore people of our State. Sir, late Prime Minister, Pandit Jawahartal Nehru had given a solemn assurance to the people of Tamil Nadu, on the floor of the Parliament, that Hindi will not be imposed on non-Hindi speaking people. Sir, the National Highways Authority's move to have Hindi inscription on the milestones in Tamil Nadu is in total contravention of Pandit Nehru's assurance. Sir, I would like to ask: Will the National Highways Authority take steps to inscribe a language like Telugu, Malayalam, or, any other South Indian language on the milestones of the national highways in Uttar Pradesh.

Sir, this three-language formula remains only on papers. Sir, the Chief Minister of Tamil Nadu has already written to the Prime Minister drawing his attention to this explosive issue.

I, therefore, appeal to the Centre to remove Hindi inscriptions forthwith from all the milestones in Tamil Nadu in deference to the sentiments of people of Tamil Nadu. Sir, the Minister of Shipping, Road Transport and

Highways who belong to my State has to give an explanation to the people of Tamil Nadu.

MR. CHAIRMAN: Please finish it.

SHRI P. G. NARAYANAN (Tamil Nadu) : Sir, the Minister owes an explanation to them.

SHRI JAIRAM RAMESH (Andhra Pradesh): Sir, I associate myself with the concern expressed by Shri P.G. Narayanan.

SHRI B.K. HARIPRASAD (Karnataka) : Sir, I also associate myself with the concern expressed by the hon. Member...(Interruptions)...

Sir, during the month of November, it was brought to my notice that a particular Member of Legislative Assembly has said -- it is on record -- that Tamil language is not there and it is being ignored in all the milestones in the State of Tamil Nadu. Immediately, I called my officers and gave them instructions that wherever new roads are there on the National Highways, milestones should be written in regional languages.

Sir, I told on 11.11.2004 itself to see that all the milestones are inscribed in Tamil language. Orders for the same have been given, and, moreover, today, I have issued orders to the NHAI saying that regional languages should be part and parcel of all the milestones of each and every State. Sir, we want to <code>have...{Interruptions}...</code> and we have done our best. ...(Interruptions)...
