mutually between Bokaro Steel Limited and the Soviet Suppliers depending on the requirements. The Government are not considering any reduction in the number of Soviet Specialists nor have they made any such suggestion to the Government of the USSR. At the end of October, 1968, 131 Soviet Specialists, including the Specialists for design supervision, were in position at Bokaro..

MULTIPLE PURCHASE OF TECHNICAL KNOW-HOW FROM ABROAD

(a) the number of cases that have come to the knowledge of Government involving multiple purchase of the same 'know-how' by different concerns; and

(b) what is the extent of the extra foreign exchange drain on this account?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED) : (a) The following is an illustrative list of industries in which several Indian parties have been allowed import of know-how for the manufacture of the same or similar product under independent agreements —

(b) The extent of extra foreign exchange drain which could have been avoided, had the negotiations for acquisition of know-how in these cases been conducted in a co-ordinated manner, cannot be worked out now. It has however to be borne in mind that all units in the various industries mentioned above were not set up at about the same time.
