†[THE MINISTER OF INDUS-TRIAL AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) to (d) A statement is laid on the Table of the House.

STATEMENT

(a) About 1200 employees of the Heavy Engineering Corporation were temporarily accommodated in two hostels of the Central Training Institute. These employees had been affected by the communal disturbances which occurred in Ranchi in August, 1967 and have been living in hostels since then.

(b) Management agreed to pay salaries to Muslim employees during their absence from duty. They also decided to advance two month's basic salary. The management has assisted these employees by (a) treating the absence of these Muslim employees as special casual leave from 22nd August, 1967 to 15th October, 1967 (b) paying salaries to these employees during their absence from duty and advancing two months basic salary (c) waiving of recovery of all advances and outstanding amounts due from employee killed in the disturbances except any cases where such advances were for purchase of motor cars and immovable properties. A sum of Rs. 500 paid as compensation in each individual cases of loss of life. (d) providing jobs to one dependent member of family of deceased employee in the Corporation,

(c) and (d) Efforts are being made by the management of the H. E. C. to disperse Muslim employees who are at present temporarily housed in some hostels to various sectors in the HEC colony. With such dispersal, and various measures, taken, the Management is attempting to ensure that the

may live together in harmony. A programme for the construction of some additional quarters is also being undertaken.]
