(b) to (d) The grade-wise resources of coal have not yet been completely assessed. During the year 1967-68, the production of selected grades of coal accounts for only 19 per cent of the total coal output.

The reserves of superior grades of coal in India are expected to last far several decades. However, in order to conserve superior grades of coal, the Coal Board is taking several steps like stowing, protective measures to prevent flooding of mines etc. under the Coal Mines (Conservation and Safety] 3—54 R. S./68

Act, 1952. Besides, steps have also been taken for adoption of scientific methods in mining as well as in utilisation of coal and setting up of washeries for washing lower grades of coal.
